# EARNINGS RESULTS

## 2Q62 ฟิ้นตัวจากฐานต่ำ

- LPH รายงานกำไรสุทธิ 2Q62 ที่ 17.7 ล้านบาท (-50%QoQ , +16%YoY) แต่หากไม่รวมรายการตั้งสำรองผลประโยชน์พนักงาน จำนวน 11 ล้านบาท และรายได้จากเงินลงทุนสุทธิของกองทุนส่วนบุคคลที่พลิกจากขาดทุน 10 ล้านบาทใน 2Q61 มามีกำไร 1.28 ล้านบาท ซึ่งเรามองว่ารายการดังกล่าวไม่ใช่ธุรกิจหลักของบริษัท บริษัทจะมีกำไรปกติที่ 27.5 ล้านบาท (-23%QoQ , +8%YoY) ทั้งนี้ผลประกอบการที่เติบโต YoY มาจาก 1) ฐานกำไรที่ต่ำปีก่อน 2) การเติบโตของกลุ่มผู้ป่วยที่รักษาโรคซับซ้อนที่เพิ่มขึ้น และการขยายธุรกิจใหม่บริการตรวจสุขภาพเคลื่อนที่ ส่งผลให้รายได้ปรับเพิ่มขึ้น 4%YoY เป็น 383 ล้านบาท
- ประสิทธิภาพในการทำกำไรลดลง โดย EBITDA Margin ปรับลดลง จาก 2Q18 ที่ 13.9% เหลือ 11.1% จากต้นทุนดำเนินงานที่สูงขึ้นจากการเริ่มธุรกิจใหม่ บริการตรวจสุขภาพเคลื่อนที่ ซึ่งมีต้นทุนพนักงาน และค่าใช้จ่ายการตลาดที่เพิ่มขึ้น

## คงคำแนะนำ "เก็งกำไร"

- แนวโน้ม 3Q62 คาดผลประกอบการจะเติบโตดีขึ้น QoQ และ YoY เนื่องจากเข้า High Season ของอุตสาหกรรม และคาดว่าจะรับประโยชน์มากขึ้นจากการขยายธุรกิจให้บริการตรวจสุขภาพเคลื่อนที่ โดยบริษัทตั้งเป้าหมายปีนี้จำนวนพนักงานตรวจสุขภาพเคลื่อนที่จะเพิ่มเป็น 2 แสนคนต่อปี จากปีก่อนแค่ราว 1 หมื่นคน ภาพรวมปี 2562 เราคาดประมาณการกำไรปกติที่ 136 ล้านบาท เติบโต 7%YoY โดยกำไรใน 1H62 คิดเป็น 47% ของประมาณการกำไรทั้งปี
- เราคงคำแนะนำ "เก็งกำไร" ด้วยแนวโน้มผลประกอบการที่ยังเติบโตใน 2Q62 แนวโน้ม 3Q62 จะเข้า High Season คาดกำไรยังเห็นการเติบโต QoQ และ YoY เราคงมูลค่าพื้นฐานในปี 2562 ที่ 5.90 บาท
